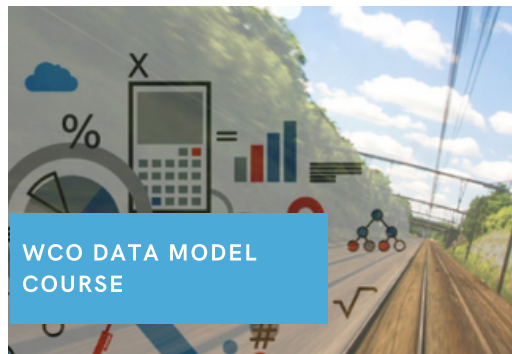

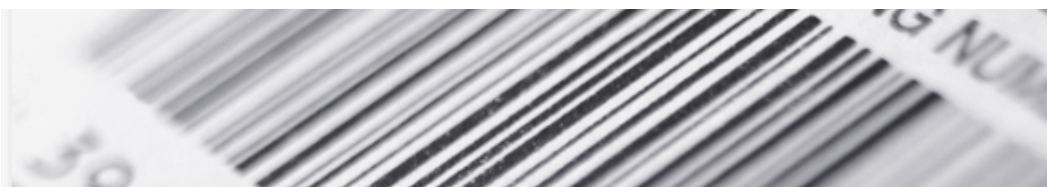

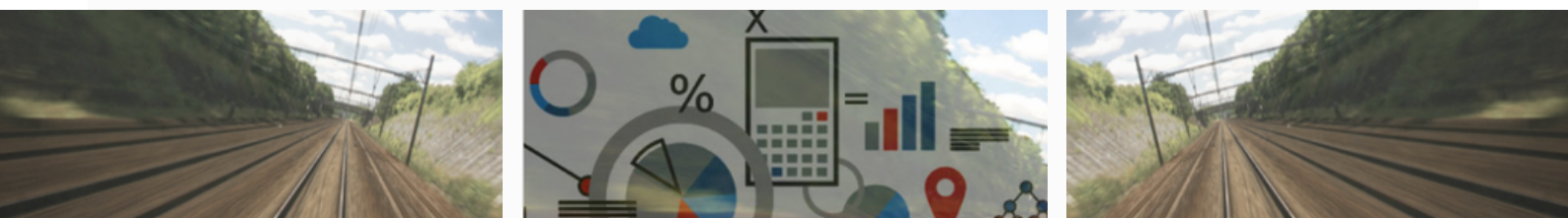

Some goods which need to be brought into a country for certain specific reasons (an exhibition, commercial demonstration, humanitarian mission, etc.) are exempt from Customs duties under the express condition that they are re-exported within a specified timeframe. The most important tools covered by the Istanbul Convention are the ATA carnet (for goods) and the CPD carnet (for vehicles), which are standardized documents used by Customs services to check temporary admissions.

### a. WTO Trade Facilitation Agreement (TFA) - Course

The Trade Facilitation Agreement (TFA) is the product of almost 10 years of World Trade Organization (WTO) negotiations. It will be legally binding once two-thirds of the World Trade Organization Members accept it, on those Members that accept it. Driven by the spectacular growth in global trade, and the urgency to reduce the time and cost of moving goods across borders, the TFA contains provisions for speeding up the movement, release and clearance of goods. It sets out best practice for cooperation between Customs and other stakeholders, and it contains provisions for technical assistance and support for nations who may need it. It should take about 5 hours to complete the course. This course has been developed with financial support from the Swedish Ministry for Foreign Affairs.
